## **Attendance Policy and Dismissal Policy**

Only authorized individuals will be able to pick up your child, and they will be required to show identification. Dismissal begins at 3:30 pm and children will not be dismissed from the program prior to 3:30 pm each day. • Students enrolled are encouraged to attend all four days of the program each week. We have committed staff assisting students and providing hands-on engaging activities during the camp up to dismissal time. It is important for each student to remain in the program for the full program hours to receive these benefits. Daily attendance is taken when your child comes to the *Drama & Drums Camp*. Regular attendance and punctuality are essential.

I understand that my child is not required to complete these surveys or interviews and that he/she can stop filling out the surveys at any time. I understand that we will not experience any negative consequences if I do not allow my child to participate in the evaluation. A written statement from the student's physician, physician assistant or advanced practice registered nurse, containing the following information:  A. The name and purpose of the medication;  B. The prescribed dosage; and  C. The time or times at which or the special circumstances under which the medication is to be administered.

The following disciplinary actions will be taken if the participant does not follow the rules of the program:  1st Verbal Warning 2nd Written warning/Phone call to parents 3rd Suspension from the program 3 days/with phone call home 4th Student will be out of the program/Parent and Student meeting  Note: Depending of the severity of the action (the Program Coordinator will decide the severity of that action), a student can be suspended or discharged from the program immediately. Also, the Program Coordinator will keep an eye on every participant's behavior, and according to it, he/she will decide if the student will be allowed to participate in certain activities.
